Client Name: *Diane* County: *Martinsville, VA*
 Case Type: *Consumer* Outcome: *Protected Income/Property*

Diane* is a 71-year-old woman living alone in Patrick County. She is disabled, but manages to get around with the help of a walker and a wheelchair. A few years ago, Diane bought a small car that was so unreliable and required so many repairs that eventually she had the dealer take the car away.

Two years later, she received a letter from the finance company saying she owed more than \$8,000 on the car, even though she had made monthly payments on the car for three years and the dealer had resold the car. On her limited monthly income of less than \$1,600, she could not afford the payment. She was also worried that legal action concerning this debt would interfere with her plans to purchase a modest mobile home.

A VLAS attorney set up an appointment in our Martinsville satellite office, so Diane would not have to travel too far, and took on the case. After a series of negotiations, Diane's VLAS attorney was able to persuade the finance company that in light of Diane's condition, it was best for all concerned to drop the matter. The finance company agreed to withdraw its lawsuit, putting Diane back on strong enough financial footing to purchase her mobile home.

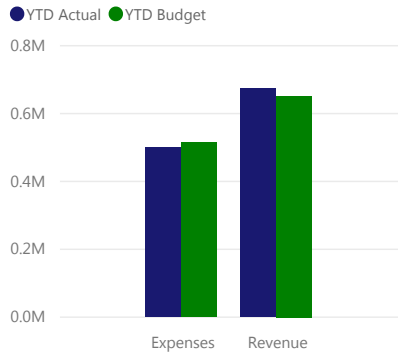

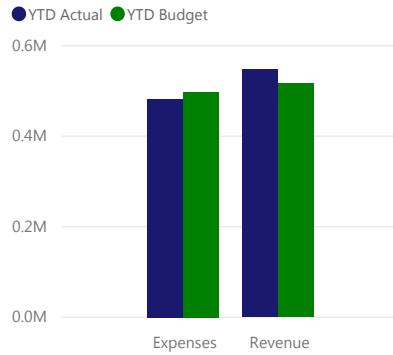

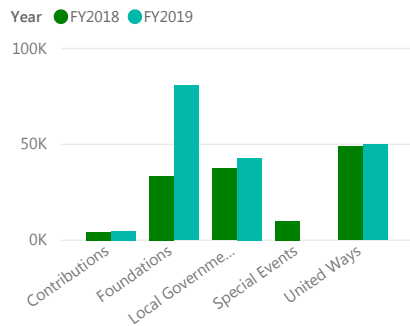
